The floor plan consists of three main areas:

- Ground Floor:** A large area with a green cross-hatch pattern representing the garden (39.4 x 24.9, 12.00 x 7.55m). Adjacent to the garden is a shed (12'6" x 9', 3.80 x 2.67m). The main house structure includes a kitchen (9'6" x 9'1", 2.90 x 2.78m), a dining room (12'3" x 11'5", 3.74 x 3.47m), and a bedroom (12'11" x 11'3", 4.23 x 3.44m). A staircase leads to the first floor.
- First Floor:** Contains three bedrooms: one measuring 10'10" x 9'8" (3.30 x 2.95), another 11'4" x 9'3" (3.46 x 2.83m), and a third 10'1" x 11'5" (4.60 x 3.47m). A staircase leads down to the ground floor.
- Outbuilding:** A separate structure, likely the shed, measuring 12'6" x 9' (3.80 x 2.67m).
