
A well presented four bedroom student property located in the Camden area of Bath. The house is located on a quiet, non through road, residential street. Available furnished, from the 1st July 2026.


On the top floor there are two further bedrooms and a shower room. Each bedroom comes with a bed, desk, chair and wardrobe.
