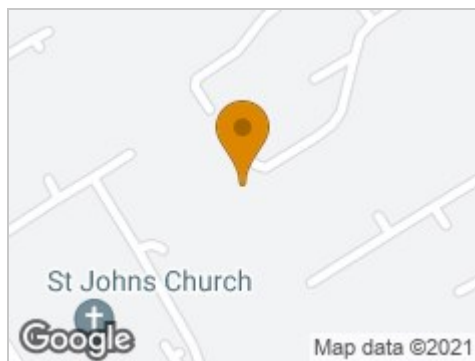

Hybrid Map



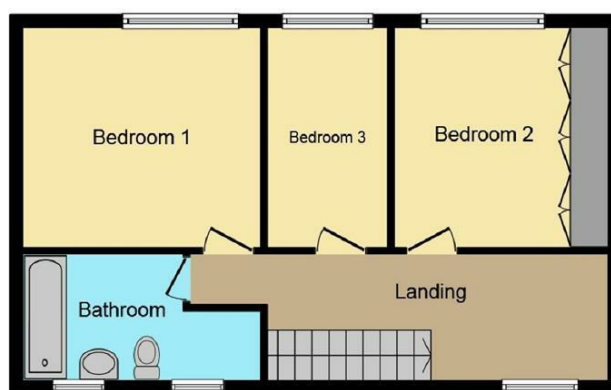
Terrain Map

First Floor

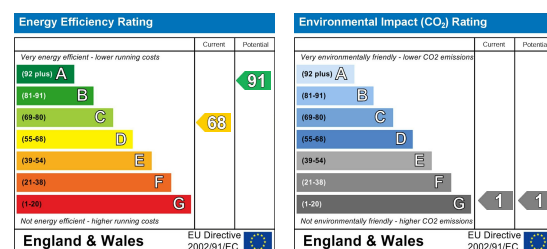
