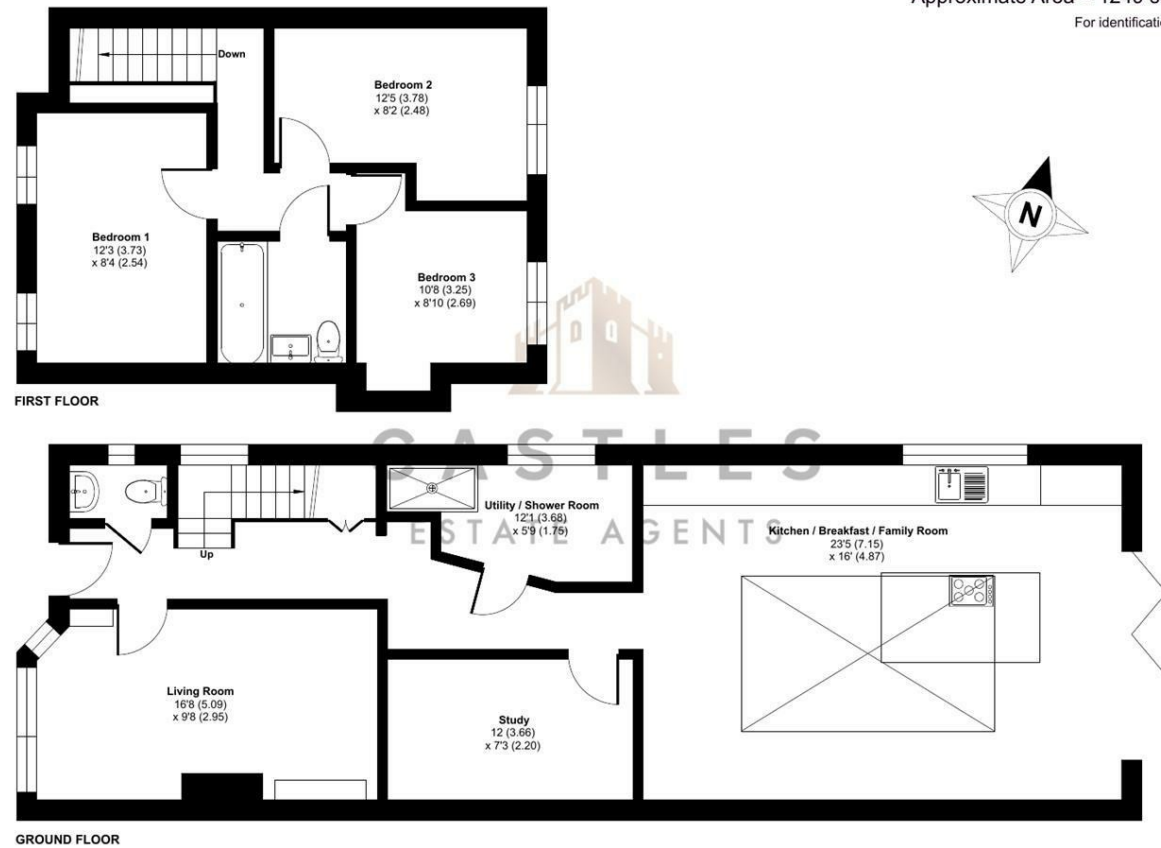


Floor Plan

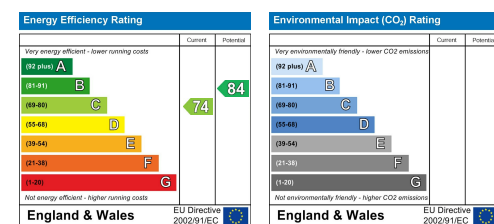
