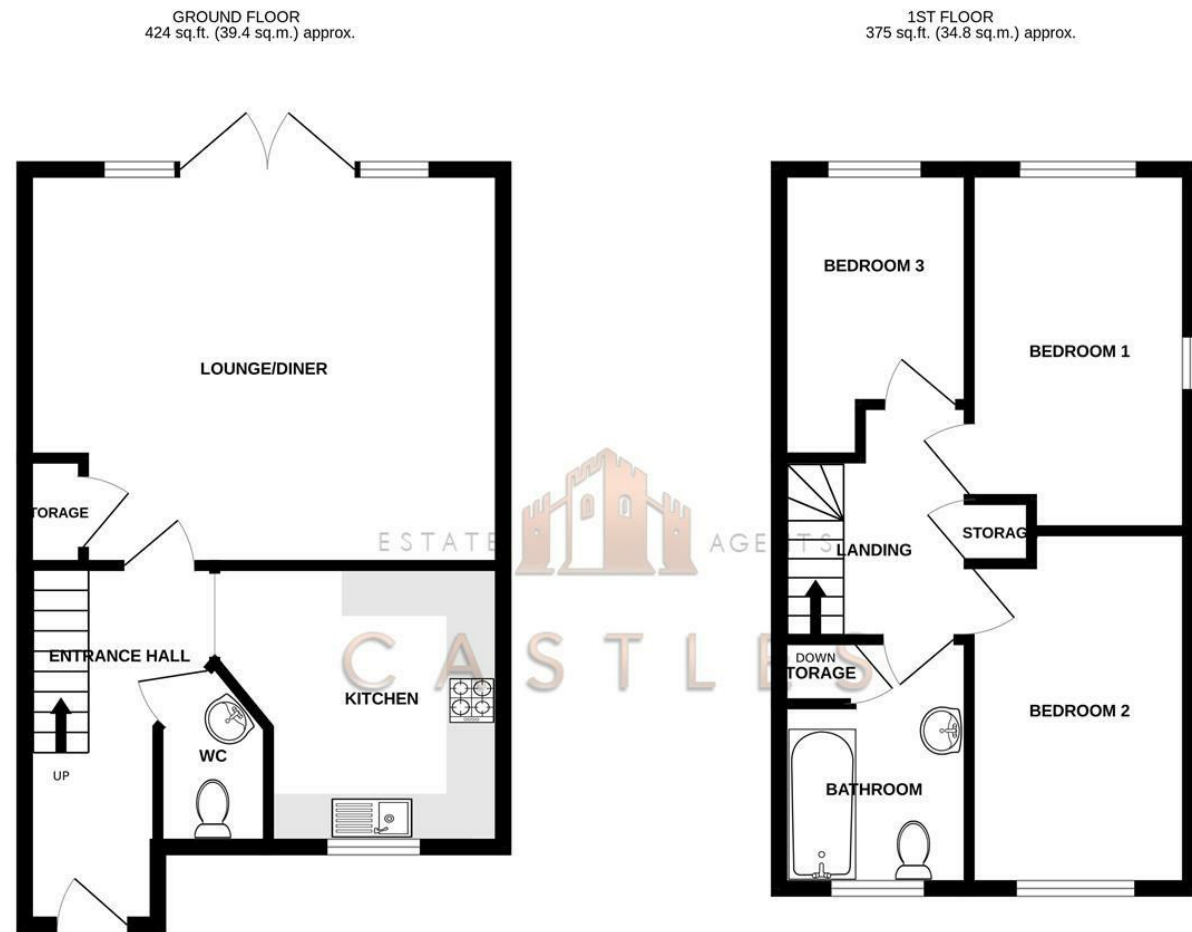


Floor Plan

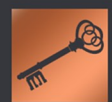

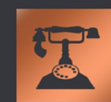
