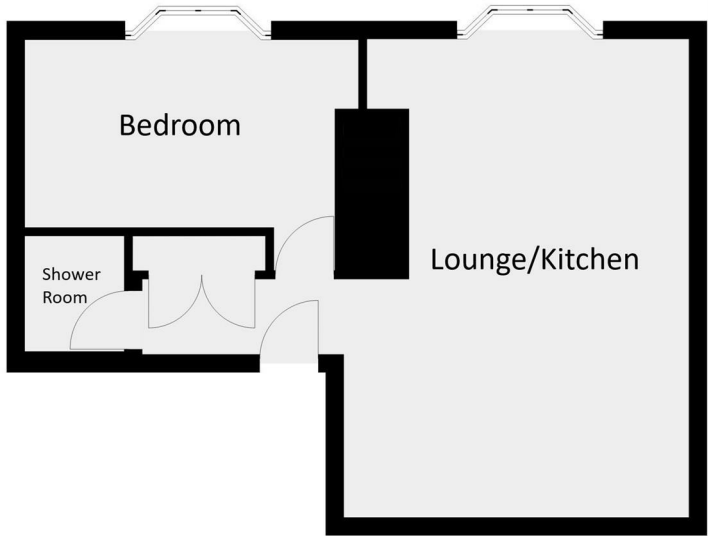
Due to the current high level of demand, we are asking all prospective tenants to submit an application form prior to viewing.
