

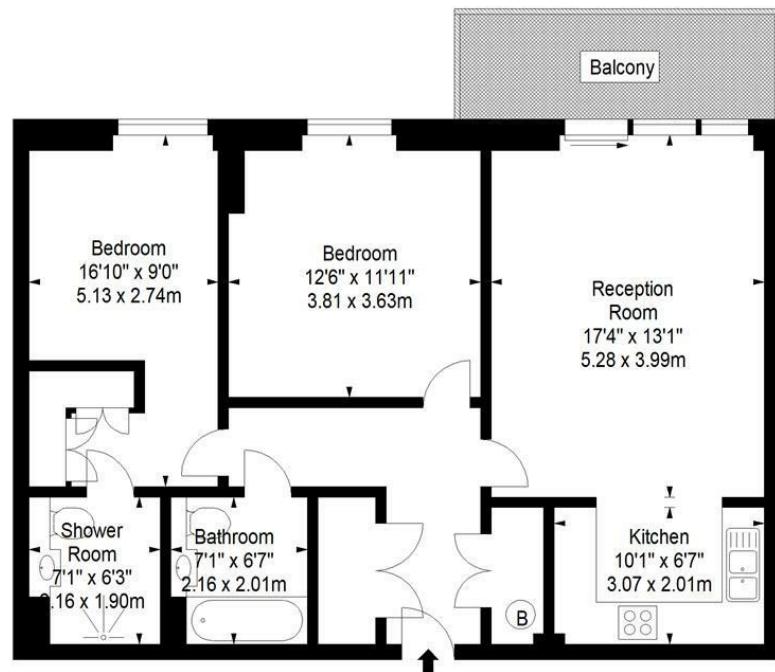


Second Floor


