Upstairs, there are two large, bright and high-ceiling double bedrooms with original wooden floorboards, serviced by a three-piece bathroom suite and boarded loft space with integrated ladder access. Externally, the front of the property offers street parking and access to the rear garden.

To the rear, a well-maintained, enclosed south-facing garden offers an outdoor haven, featuring a spacious block-paved seating area perfect for alfresco dining, mature plant beds modelled around a neatly kept lawn, and a secure fence-panelled boundary that enhances privacy. At the end of the garden is a versatile garden room which is currently being utilised as a craft room and playroom - the perfect outdoor retreat.

The living room has carpeted flooring, a feature fireplace with a decorative surround and a hearth, a radiator, an in-built base unit, coving to the ceiling, a ceiling rose, a UPVC double-glazed window to the front elevation, an overhead window to the front elevation, and a single door providing access into the accommodation.




