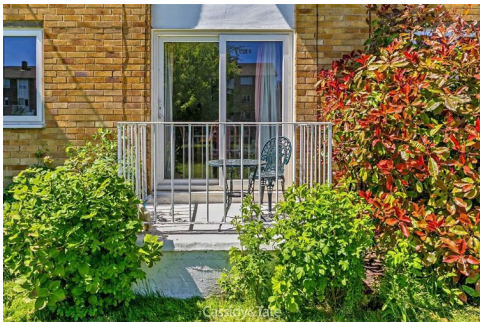

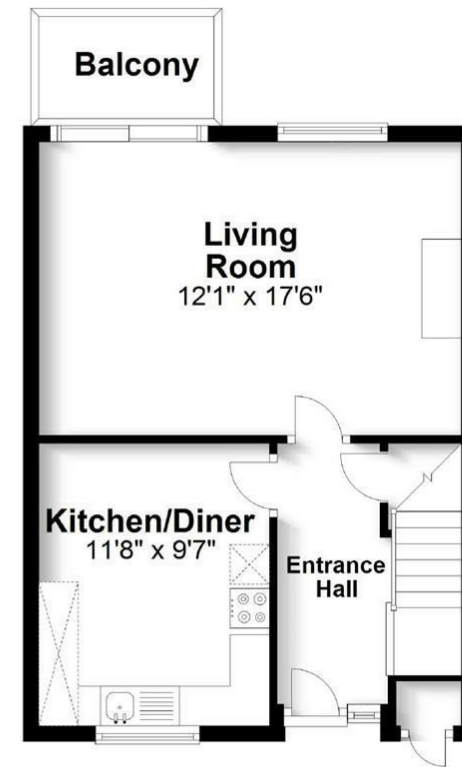

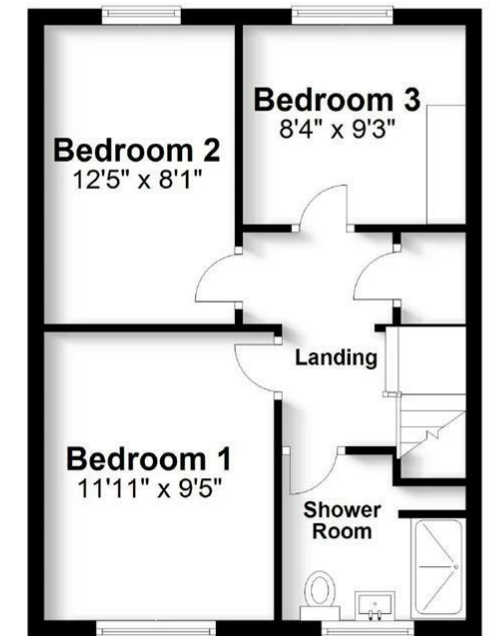
Ground Floor
