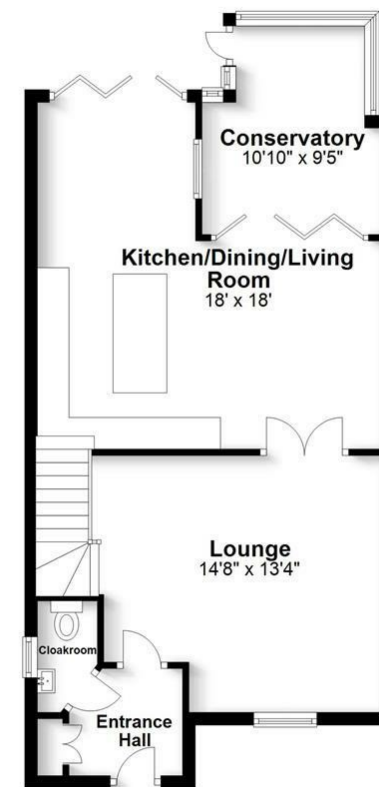

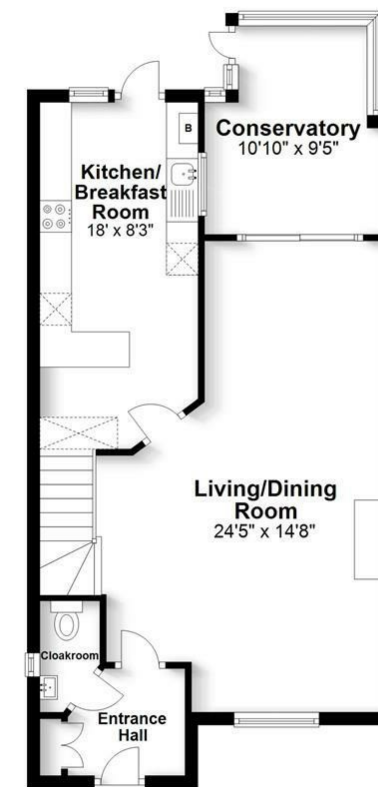

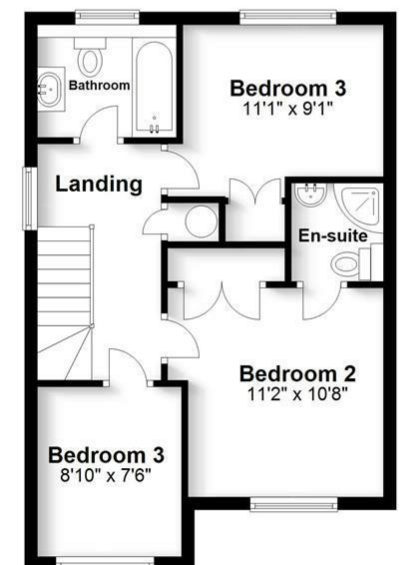
Proposed Ground Floor
