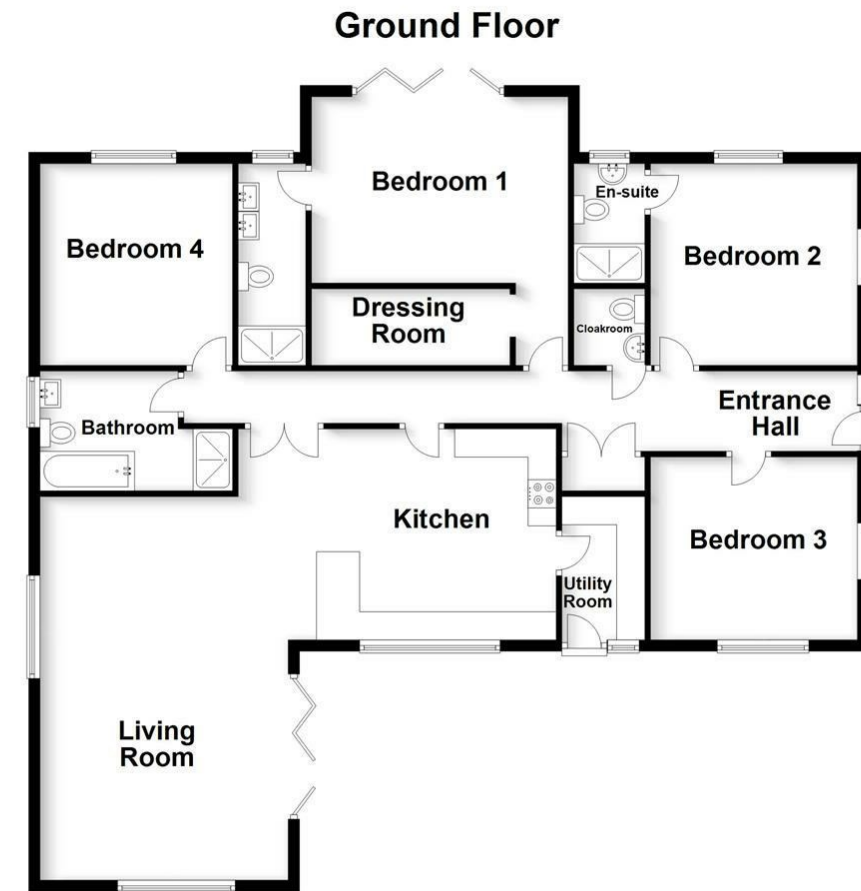

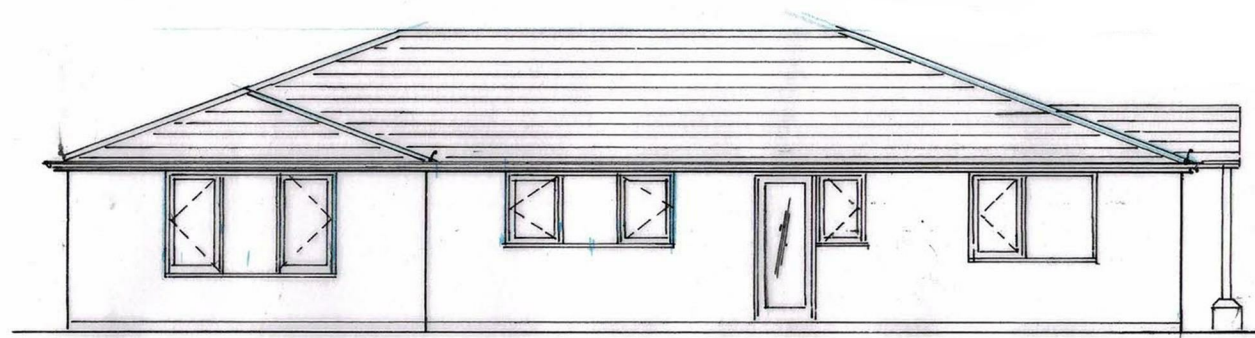

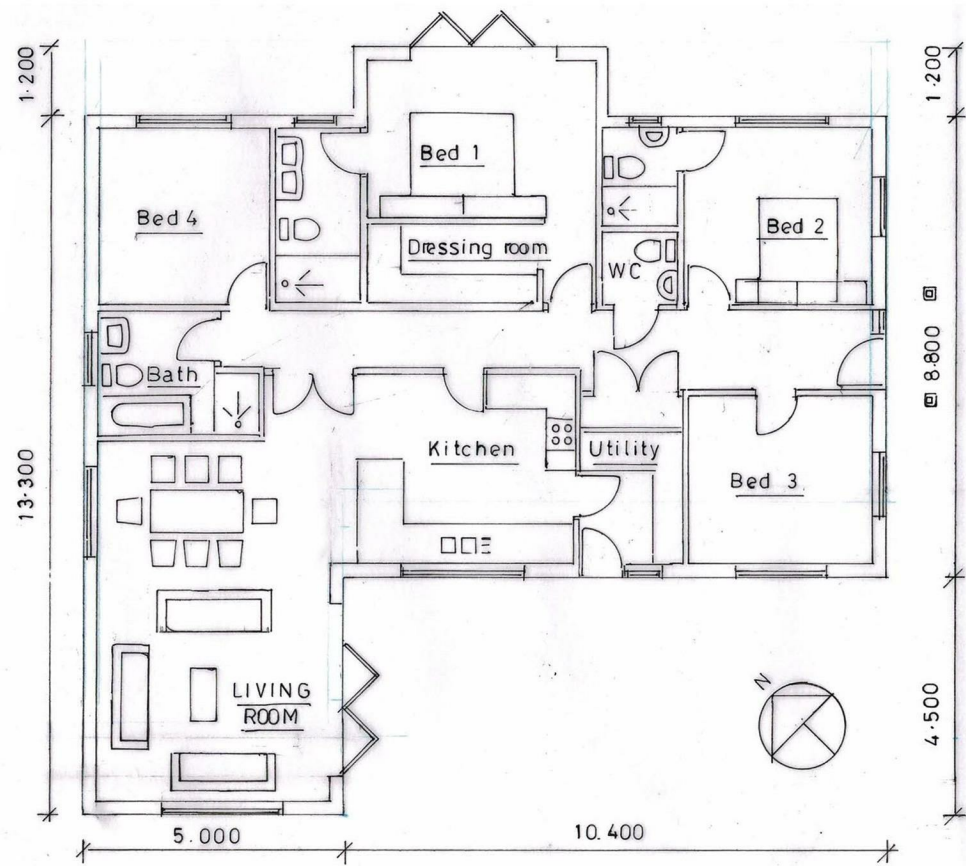

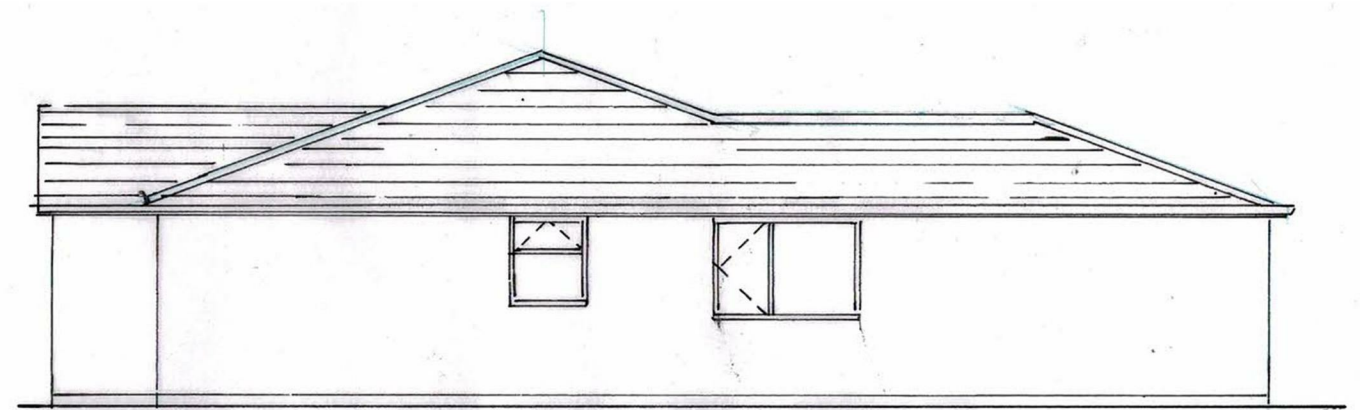
SIDE ELEVATION S.East
