Double glazed door to rear and central heating radiator

#### Kitchen

Double glazed window to front, range of wall and base units with work surface over incorporating sink with mixer tap, gas hob with extractor hood over, space and plumbing for washing machine, central heating radiator, boiler and integrated oven

#### Cloakroom

Low level w.c, wash hand basin with mixer tap, central heating radiator and extractor fan

#### Landing

Double glazed window to side, cupboard off and access to loft space

#### Bedroom One

Double glazed window to rear, central heating radiator and built in wardrobe

#### Bedroom Two

Double glazed window to front and central heating radiator

#### Bedroom Three

Double glazed window to rear and central heating radiator

#### Bathroom

Low level w.c, wash hand basin with mixer tap, double glazed window to front, bath with mixer tap and shower over, tiled splash backs, central heating radiator and extractor fan

#### Garden

Lawn, slab patio area, decking, side gate and fencing to enclose

Up and over door to front

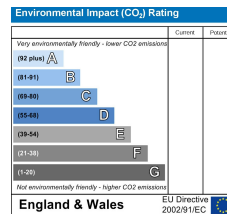
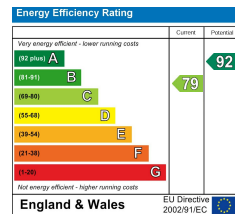
### Tenure (Freehold).

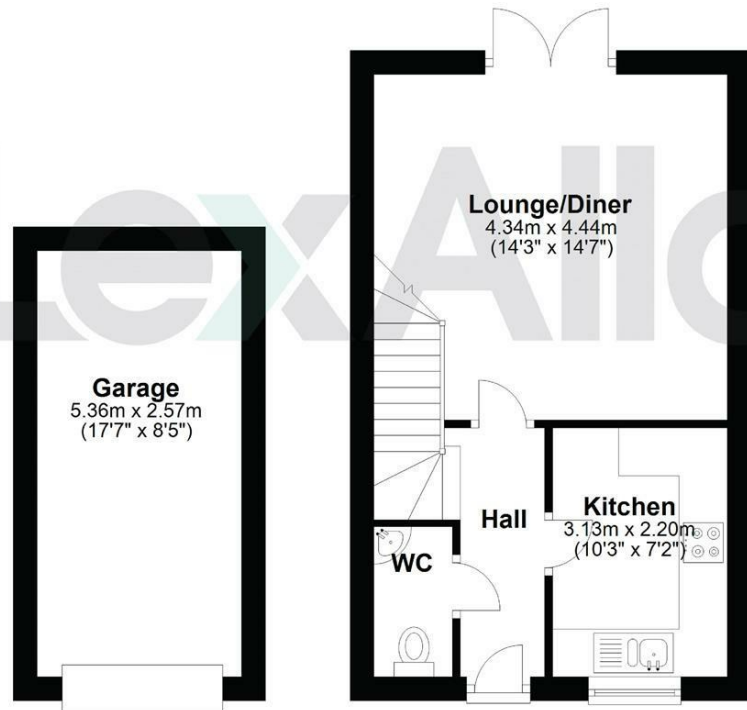






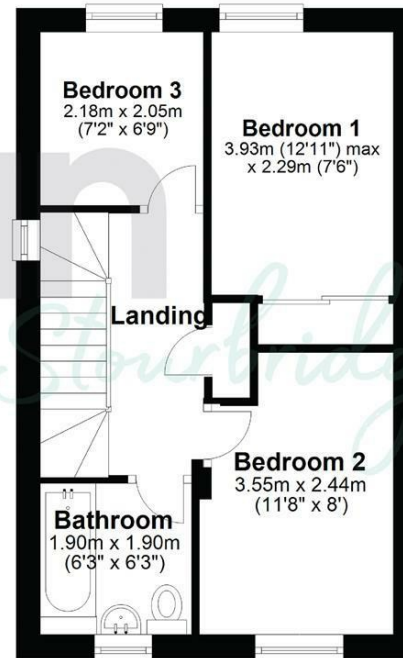
## Ground Floor
