Tarmac drives to front and side offering ample parking and lawns.

Entrance Hall

Door to front, stairs off and central heating radiator.

Lounge

11'5" max 8'10" min x 17'0" (3.5 max 2.7 min x 5.2)

Double glazed window to front, central heating radiator and gas fire.

Kitchen/Diner

15'8" min 24'11" max x 10'5" (4.8 min 7.6 max x 3.2)

Double glazed window to front, range of wall and base units with work surface over incorporating sink with mixer tap, gas hob with extractor hood over, integrated dishwasher, fridge, freezer, oven, central heating radiator and doors to rear.

Downstairs WC

Wash hand basin, WC and double glazed window to front.

Landing

Double glazed window to side, access to loft space and doors off.

Bedroom One

Double glazed window to front, central heating radiator and built in wardrobe.



