Approach

Block paved driveway offering parking for a number of cars.

Entrance Hall

Double glazed door to front, central heating radiator and stairs off.

Lounge

Double glazed window front, gas fire and central heating radiator.

Kitchen

Double glazed window to rear, door to side, range of wall and base units with work surface over incorporating sink with mixer tap, gas oven and hob with extractor hood over, tiled splash backs, space and plumbing for washing machine, combination boiler and cupboard off.

Landing

Double glazed window to side, access to loft space and doors off.

Bedroom One

Double glazed window to front, central heating radiator and cupboard off.

Bedroom Two

Double glazed window to rear and central heating radiator.

Bathroom

Double glazed window to rear, WC, wash hand basin with mixer tap, bath with shower over, central heating radiator, tiled splash backs and extractor fan.

Garage

Main door to front, further door to side and double glazed window to rear.

Rear Garden

Patio, lawn, flower beds, slate chip bedding, shed, side access via gate and all with fencing and walls to enclose.

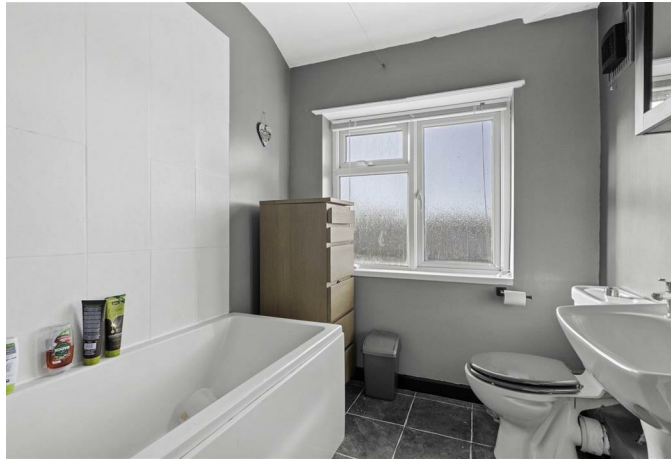

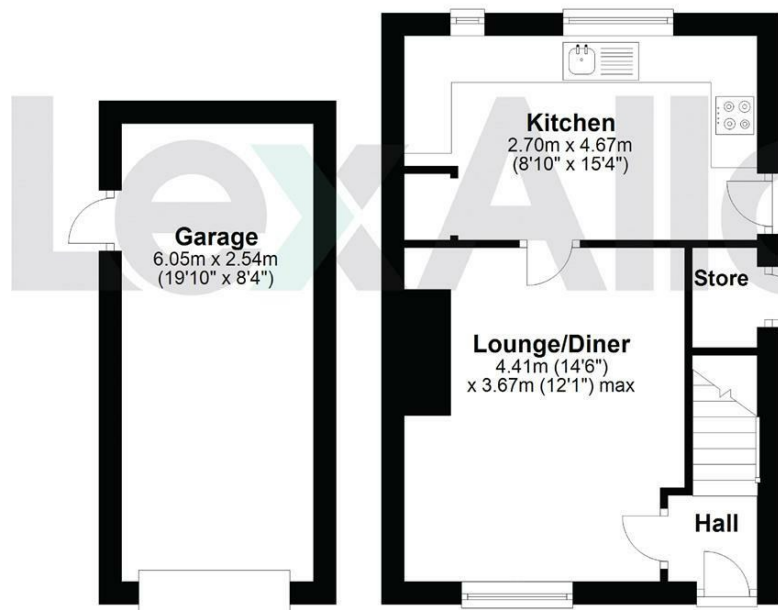

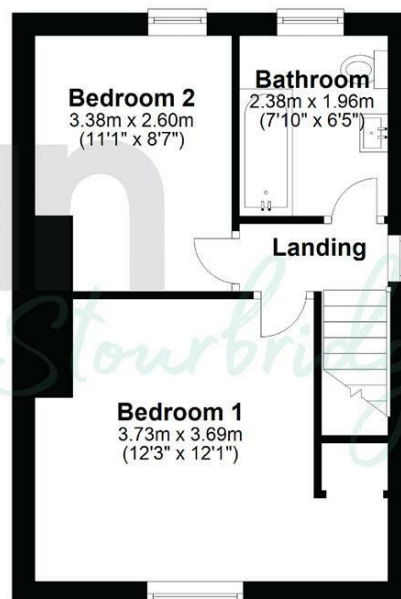
Ground Floor
