Double glazed window to front, electric fire and central heating radiator

Kitchen

Double glazed window to rear and door to side, range of wall and base units with work surface over incorporating sink with mixer tap, induction hob with extractor hood over, integrated oven and microwave, tiled splash backs, central heating radiator, cupboard off and space and plumbing for washing machine

Double glazed doors to rear and side and central heating radiator

Space for dryer or washer

Half Garage

Up and over door to front

Access to loft space, cupboard and doors off

Bedroom One

Double glazed window to front, central heating radiator and built in wardrobe

Bedroom Two

Double glazed window to rear, central heating radiator and cupboard off

Bedroom Three

Double glazed window to rear and central heating radiator

Bedroom Four

Double glazed window to front and cupboard off



Bathroom

Double glazed window to rear, low level w,c, wash hand basin with mixer tap, bath with mixer tap and shower over, heated towel rail and tiled splash backs

Block paved patio, lawn, planted flower beds, gated side access and all with fencing and hedging to enclose
