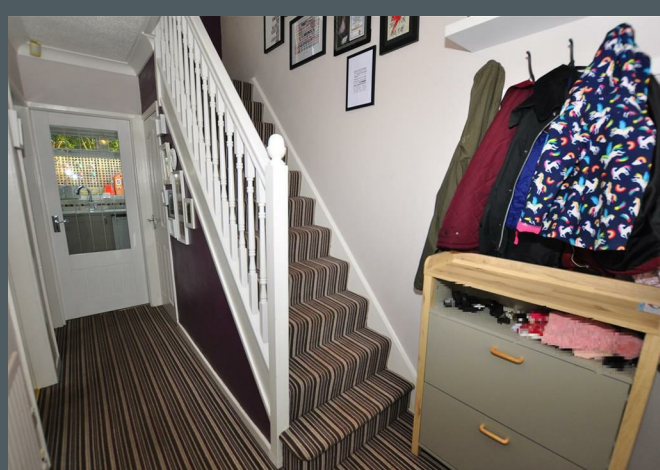

### Location

Halesowen lies approximately 7 miles from Birmingham City Centre and is just minutes away from junction 3 of the M5 motorway giving access to the greater motorway network all around the West Midlands. The History of Halesowen stems back as far as the Anglo Saxons and it was listed in the Domesday Book as being larger than Birmingham. It forms part of the southern edge of the Black Country and during the industrial revolution it became synonymous with nail and screw making, an industry that still survives to a lesser extent today. Despite its proximity to the Black Country it still retains areas of beauty and Grade I listed Leasowes Park is thought to be one of the first natural landscape gardens in England. In certain areas the town is predominated by a vast array of Victorian houses but further development during the 1960's and 70's saw the building of several large housing estates. It has a number of highly sought after primary and secondary schools. Whilst Halesowen no longer has a train station of its own the Worcester to Birmingham line passes along the northern edge of its boundary and the stations of Cradley Heath, Old Hill and Rowley Regis are all within a few miles of the town centre. Halesowen bus station is a busy interchange and regular service runs to Birmingham City Centre.

Via tarmac driveway offering parking for a number of cars, lawn area with beds housing various plants and shrubs.

#### Entrance hall

With double glazed window and door to front, central heating radiator, stairs to first floor accommodation.

#### Lounge 10'9" min 12'1" max x 11'9" (3.3 min 3.7 max x 3.6)

Gas fire, feature surround, double glazed bay window to front, central heating radiator.

#### Dining room 9'10" x 11'1" (3.0 x 3.4)

Double glazed door to rear, central heating radiator.

#### Kitchen diner 13'9" x 6'6" min 13'9" max (4.2 x 2.0 min 4.2 max)

Double glazed window and door to rear, range of

wall and base units with work surface over incorporating sink with mixer tap, hob with extractor hood over, integrated oven, tiled flooring and splashbacks, central heating radiator.

#### Downstairs w.c.

With low level w.c., wash hand basin with mixer tap over and storage below, tiled flooring and splashbacks, extractor fan.

#### Garage 9'6" x 7'2" (2.9 x 2.2)

With metal door to front.

#### First floor landing

Double glazed window to side, access to loft space and doors radiating to:

#### Bedroom one 8'6" x 11'9" min 14'9" max (2.6 x 3.6 min 4.5 max)

Double glazed bay window to front, central heating radiator, built in wardrobe.



**Bedroom two 9'6" x 11'1" (2.9 x 3.4)**

Double glazed window to rear, central heating radiator.

**Bedroom three 7'6" x 6'2" min 8'10" max (2.3 x 1.9 min 2.7 max)**

Double glazed window to front, central heating radiator.

**House bathroom**

With wash hand basin with mixer tap over and storage below, bath with mixer tap, double glazed window to rear, cupboard off, shower enclosure with shower over, low level w.c., tiled splashbacks, extractor fan and heated towel rail.

**Rear garden**

Slabbed patio, lawn, slabbed pathway, decked seating area, beds with various plants and shrubs and all with fencing to enclose.

**Tenure**
