## Location

Halesowen lies approximately 7 miles from Birmingham City Centre and is just minutes away from junction 3 of the M5 motorway giving access to the greater motorway network all around the West Midlands. The History of Halesowen stems back as far as the Anglo Saxons and it was listed in the Domesday Book as being larger than Birmingham. It forms part of the southern edge of the Black Country and during the industrial revolution it became synonymous with nail and screw making, an industry that still survives to a lesser extent today. Despite its proximity to the Black Country it still retains areas of beauty and Grade I listed Leasowes Park is thought to be one of the first natural landscape gardens in England. In certain areas the town is predominated by a vast array of Victorian houses but further development during the 1960's and 70's saw the building of several large housing estates. It has a number of highly sought after primary and secondary schools. Whilst Halesowen no longer has a train station of its own the Worcester to Birmingham line passes along the northern edge of its boundary and the stations of Cradley Heath, Old Hill and Rowley Regis are all within a few miles of the town centre. Halesowen bus station is a busy interchange and regular service runs to Birmingham City Centre.

Via slabbed driveway offering parking and lawn to side with beds and hedging.

## Entrance hall

Central heating radiator, entrance door to front, stairs to first floor accommodation, cupboard off.

## Dining room 10'9" x 11'9" (3.3 x 3.6)

Double glazed window to front, central heating radiator.

## Lounge 13'1" x 10'9" max 9'10" min (4.0 x 3.3 max 3.0 min)

Central heating radiator, gas fire, double glazed window to rear.



### **Kitchen 9'6" x 6'10" (2.9 x 2.1)**

Double glazed window to rear, central heating radiator, range of wall and base units with work surface over incorporating sink with mixer tap, gas hob and extractor hood over, oven, tiling to splashbacks, integrated fridge and freezer and washer dryer.

### **Lean-to 8'2" x 25'7" (2.5 x 7.8)**

Double doors to front.

Double glazed window to front, central heating radiator.

### **Bedroom three 7'2" x 9'10" (2.2 x 3.0)**

With double glazed window to front and side, central heating radiator.

### **House bathroom**

Bath with mixer tap over, double glazed window to rear, wash hand basin, heated towel rail and tiling to splashbacks.

### **Separate w.c.**

Low level w.c. and window to side.

### **Rear garden**

Slabbed patio area, tiered lawns, beds and all with timber fencing to enclose.
