## Location

Halesowen lies approximately 7 miles from Birmingham City Centre and is just minutes away from junction 3 of the M5 motorway giving access to the greater motorway network all around the West Midlands. The History of Halesowen stems back as far as the Anglo Saxons and it was listed in the Domesday Book as being larger than Birmingham. It forms part of the southern edge of the Black Country and during the industrial revolution it became synonymous with nail and screw making, an industry that still survives to a lesser extent today. Despite its proximity to the Black Country it still retains areas of beauty and Grade I listed Leasowes Park is thought to be one of the first natural landscape gardens in England. In certain areas the town is predominated by a vast array of Victorian houses but further development during the 1960's and 70's saw the building of several large housing estates. It has a number of highly sought after primary and secondary schools. Whilst Halesowen no longer has a train station of its own the Worcester to Birmingham line passes along the northern edge of its boundary and the stations of Cradley Heath, Old Hill and Rowley Regis are all within a few miles of the town centre. Halesowen bus station is a busy interchange and regular service runs to Birmingham City Centre.

## Approach

Via block paved driveway offering parking for a number of cars and slate chipped bedding.

## Porch

Double glazed window and door to front.

## Entrance hall

With double glazed door to front, cupboard off, stairs to first floor accommodation, central heating radiator, double glazed window to front.

## Lounge 9'10" min 11'1" max x 18'8" (3.0 min 3.4 max x 5.7 )

With double glazed door to rear, central heating radiator and gas fire, archway opening to diner.

Central heating radiator, double glazed window to rear.

**Kitchen 6'6" x 13'9" (2.0 x 4.2)**

Double glazed window to front, double glazed door to side, range of wall and base units with work surface over incorporating sink with mixer tap, space and plumbing for washing machine, tiled splashbacks, gas hob and cooker with extractor hood over.

**Conservatory 7'6" x 11'1" (2.3 x 3.4)**

With double glazed windows and door, tiled flooring.

With double glazed window to front, central heating radiator.

**House bathroom**

Double glazed window to rear, central heating radiator, low level w.c., bath with mixer tap over, wash hand basin with storage below, cupboard housing immersion tank, tiling to splashbacks.

**Rear garden**

With slabbed patio and pathway, lawn, beds housing various plants and shrubs, two sheds and all with fencing to enclose.
