Location

Halesowen lies approximately 7 miles from Birmingham City Centre and is just minutes away from junction 3 of the M5 motorway giving access to the greater motorway network all around the West Midlands. The History of Halesowen stems back as far as the Anglo Saxons and it was listed in the Domesday Book as being larger than Birmingham. It forms part of the southern edge of the Black Country and during the industrial revolution it became synonymous with nail and screw making, an industry that still survives to a lesser extent today. Despite its proximity to the Black Country it still retains areas of beauty and Grade I listed Leasowes Park is thought to be one of the first natural landscape gardens in England. In certain areas the town is predominated by a vast array of Victorian houses but further development during the 1960's and 70's saw the building of several large housing estates. It has a number of highly sought after primary and secondary schools. Whilst Halesowen no longer has a train station of its own the Worcester to Birmingham line passes along the northern edge of its boundary and the stations of Cradley Heath, Old Hill and Rowley Regis are all within a few miles of the town centre. Halesowen bus station is a busy interchange and regular service runs to Birmingham City Centre.

Approach

Via a tarmac driveway with fore garden. The front door opens into:

Reception room 13'9" x 12'1" (4.2 x 3.7)

With double glazed window to front, wall panel electric heater and television point.

Inner lobby

Having storage cupboards housing the water cylinder and doors radiating to:

Kitchen 8'10" x 5'2" (2.7 x 1.6)

Wall and base units, roll top work surfaces, stainless steel sink with drainer, space for under counter fridge/freezer and space for a freestanding oven, plumbing for automatic washing machine, double glazed window to side and wall panel electric heater.

Bedroom 10'9" x 8'10" excluding wardrobes (3.3 x 2.7 excluding wardrobes)

Double glazed window to rear, wall panel electric heater and fitted wardrobe storage.

Bathroom

Obscured double glazed window to rear, tiled flooring and walls, w.c., pedestal hand basin, bath with shower head over top, extractor fan and wall mounted unit.

Outside

The property benefits from a communal rear garden with lawn areas.
