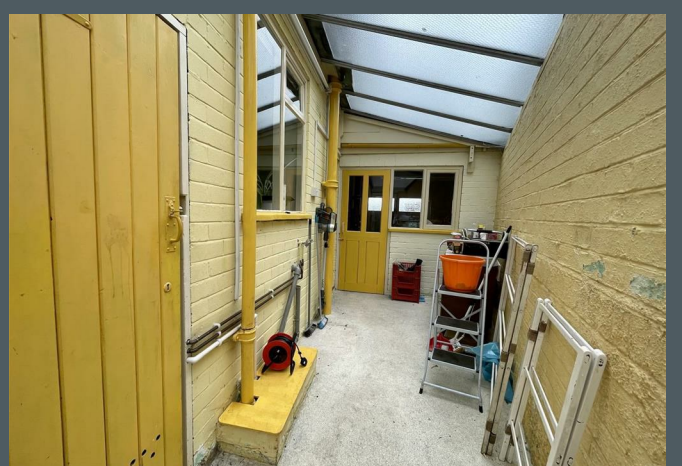

Location

Halesowen lies approximately 7 miles from Birmingham City Centre and is just minutes away from junction 3 of the M5 motorway giving access to the greater motorway network all around the West Midlands. The History of Halesowen stems back as far as the Anglo Saxons and it was listed in the Domesday Book as being larger than Birmingham. It forms part of the southern edge of the Black Country and during the industrial revolution it became synonymous with nail and screw making, an industry that still survives to a lesser extent today. Despite its proximity to the Black Country it still retains areas of beauty and Grade I listed Leasowes Park is thought to be one of the first natural landscape gardens in England. In certain areas the town is predominated by a vast array of Victorian houses but further development during the 1960's and 70's saw the building of several large housing estates. It has a number of highly sought after primary and secondary schools. Whilst Halesowen no longer has a train station of its own the Worcester to Birmingham line passes along the northern edge of its boundary and the stations of Cradley Heath, Old Hill and Rowley Regis are all within a few miles of the town centre. Halesowen bus station is a busy interchange and regular service runs to Birmingham City Centre.

Approach

Via a tarmac and block paved driveway, tidy front garden with planted borders. A wide double glazed porch opens into:

Entrance hall

With central heating radiator, under stairs store cupboard.

Front reception room 13'9" max 11'9" min x 18'0" max 10'5" min (4.2 max 3.6 min x 5.5 max 3.2 min)

Double glazed window to front, central heating radiator.







Second reception room 12'9" max 11'1" min x 10'2" (3.9 max 3.4 min x 3.1)

Double glazed window to rear, central heating radiator, t.v. point.

Kitchen 9'10" x 6'10" (3.0 x 2.1)

Selection of wall and base units with roll top work surfaces, stainless steel sink and drainer, window overlooking lean-to, central heating radiator, space for fridge freezer, door to lean-to

Lean-to

Having plumbing for automatic washing machine, storage cupboard housing Ideal boiler, door to rear garden and internal door giving access to garage.

First floor landing

Obscured double glazed window to side, doors radiating to:

Master bedroom 11'9" max 11'1" min x 10'2" (3.6 max 3.4 min x 3.1)

Double glazed window to front with views towards Clent and Walton Hills, central heating radiator.

Bedroom two 12'9" max 11'1" min x 10'2" (3.9 max 3.4 min x 3.1)

Double glazed window to rear, central heating radiator.

Bedroom three 6'10" x 6'10" (2.1 x 2.1)

Double glazed window to front, central heating radiator, access to loft space.

House bathroom

Obscured double glazed window to rear, double walk in shower cubicle with electric shower over, vanity unit wash hand basin with mixer tap, w.c., storage with shelving, central heating radiator.

Rear garden

Block paved patio areas, path throughout garden, lawn areas, mature planted borders all with fencing to boundary.
