



### Location

Halesowen lies approximately 7 miles from Birmingham City Centre and is just minutes away from junction 3 of the M5 motorway giving access to the greater motorway network all around the West Midlands. The History of Halesowen stems back as far as the Anglo Saxons and it was listed in the Domesday Book as being larger than Birmingham. It forms part of the southern edge of the Black Country and during the industrial revolution it became synonymous with nail and screw making, an industry that still survives to a lesser extent today. Despite its proximity to the Black Country it still retains areas of beauty and Grade I listed Leasowes Park is thought to be one of the first natural landscape gardens in England. In certain areas the town is predominated by a vast array of Victorian houses but further development during the 1960's and 70's saw the building of several large housing estates. It has a number of highly sought after primary and secondary schools. Whilst Halesowen no longer has a train station of its own the Worcester to Birmingham line passes along the northern edge of its boundary and the stations of Cradley Heath, Old Hill and Rowley Regis are all within a few miles of the town centre. Halesowen bus station is a busy interchange and regular service runs to Birmingham City Centre.

### **Approach**

Via tarmac driveway offering parking for a number of cars with lawned area to side, slabbed path leading to:

### **Entrance hall**

Central heating radiator, double glazed door to front and side, stairs to first floor accommodation.

# Lounge 16'0" max 15'1" min x 11'1" (4.9 max 4.6 min x 3.4)

Double glazed window and door to rear, gas fire with feature surround.













# Dining room 7'10" x 9'6" (2.4 x 2.9)

With double glazed window to side, central heating radiator.

# Kitchen 8'2" x 8'10" (2.5 x 2.7)

Double glazed window to front, range of wall and base units with work surface over incorporating sink with mixer tap, ceramic hob with extractor hood over, oven, tiling to splashbacks, space and plumbing for washing machine, combination boiler.

# Downstairs w.c.

Low level w.c., wash hand basin, double glazed window to side, central heating radiator, tiling to splashbacks.

# First floor landing

Double glazed window to side, access to loft space, cupboard off and doors radiating to:

# Bedroom ne 14'5" max 10'9" min x 9'6" (4.4 max 3.3 min x 2.9)

Double glazed window to front, built in wardrobes, central heating radiator.

# Bedroom two 9'2" x 7'10" (2.8 x 2.4)

Central heating radiator, double glazed window to rear

# Bedroom three 7'10" max 4'11" min x 10'9" (2.4 max 1.5 min x 3.3)

Central heating radiator, double glazed window to rear

### House bathroom

Bath with mixer tap over and shower, double glazed window to side, wash hand basin with mixer tap over, low level w.c., central heating radiator, fully tiled walls, built in cupboard.

### Rear garden

With slabbed patio area, beds with various plants



and shrubs, gravelled seating area and all with timber fencing to enclose.

### Garage

Metal up and over door to front.
