### Location

Halesowen lies approximately 7 miles from Birmingham City Centre and is just minutes away from junction 3 of the M5 motorway giving access to the greater motorway network all around the West Midlands. The History of Halesowen stems back as far as the Anglo Saxons and it was listed in the Domesday Book as being larger than Birmingham. It forms part of the southern edge of the Black Country and during the industrial revolution it became synonymous with nail and screw making, an industry that still survives to a lesser extent today. Despite its proximity to the Black Country it still retains areas of beauty and Grade I listed Leasowes Park is thought to be one of the first natural landscape gardens in England. In certain areas the town is predominated by a vast array of Victorian houses but further development during the 1960's and 70's saw the building of several large housing estates. It has a number of highly sought after primary and secondary schools. Whilst Halesowen no longer has a train station of its own the Worcester to Birmingham line passes along the northern edge of its boundary and the stations of Cradley Heath, Old Hill and Rowley Regis are all within a few miles of the town centre. Halesowen bus station is a busy interchange and regular service runs to Birmingham City Centre.

### Approach

Via a block paved driveway with a front lawn garden.

### Entrance hall

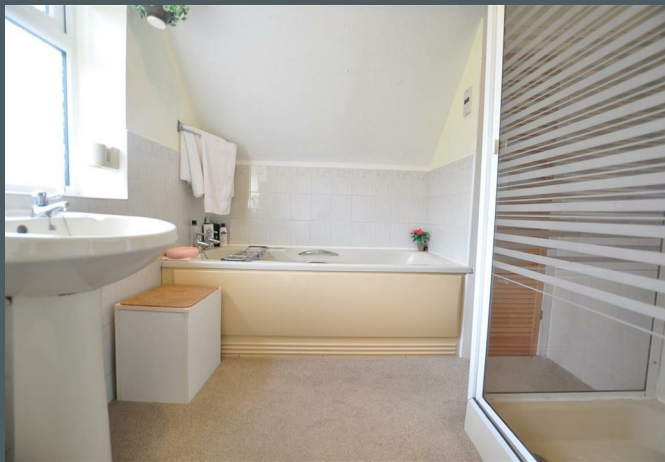
With stairs to first floor accommodation, central heating radiator, door to dining room and kitchen.

### Lounge 14'1" x 11'1" (4.3 x 3.4)

Two wall mounted light points, gas fire point, central heating radiator, double glazed patio door to rear garden.











**Kitchen 6'10" x 13'1" (2.1 x 4.0)**

Range of wall and base units, central heating radiator, stainless steel sink unit and drainer, walls part tiled, double glazed window to rear, double glazed frosted window to side.

**Dining room 13'1" x 11'1" (4.0 x 3.4)**

Double glazed bay window to front, central heating radiator.

**Utility 14'1" x 4'11" max (4.3 x 1.5 max)**

**Downstairs w.c.**

With w.c., wash hand basin, walls part tiled, double glazed frosted window to rear, extractor fan.

**First floor landing**

Access to loft space, double glazed window to side.

Double glazed bay window to front, central heating radiator, built in wardrobe and storage space.

**Bedroom two 10'9" x 8'10" (3.3 x 2.7)**

Double glazed window to rear, central heating radiator, built in wardrobe and storage space.

**Bedroom three 7'10" x 7'10" (2.4 x 2.4)**

Double glazed window to front, central heating radiator, built in wardrobe and storage space, built in drawers.

**House bathroom**

With w.c., wash hand basin, panelled bath with mixer tap, enclosed shower, double glazed frosted window to rear, built in storage cupboard, shaver point, central heating radiator, walls part tiled.

**Rear garden**

Slabbed patio area with steps leading to further slabbed pathway with lawn either side, mature planted bedding, wooden shed and greenhouse to rear.

**Garage 18'0" x 6'10" (5.5 x 2.1)**

Housing combination boiler, electric and gas meters and garage door to front.
