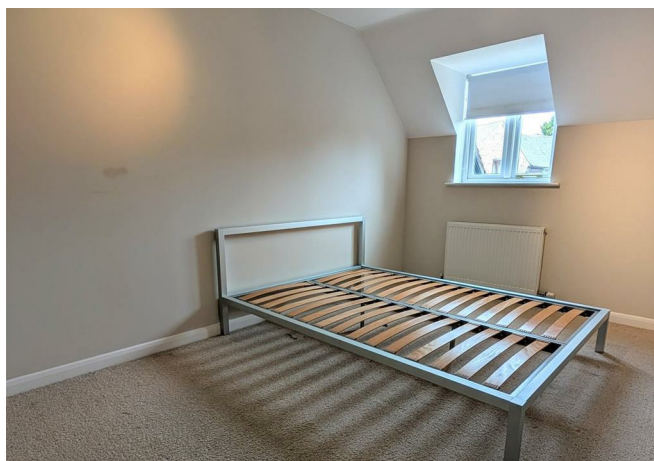

OUTSIDE THE PROPERTY

The property is approached over a brick-laid driveway, with two parking spaces, a gravelled area and a slabbed pathway leading to the front of the property where there is an outside seating area.

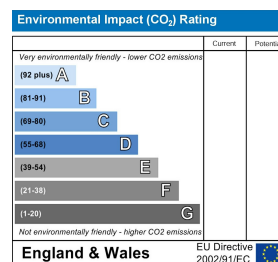
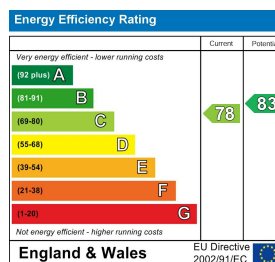
