Double bedroom with two front aspect double glazed windows and radiator. Built-in wardrobe with sliding doors.

Being partially tiled having a panelled bath with electric shower over. Pedestal wash basin and low-level flush WC. Rear aspect double glazed window and radiator.

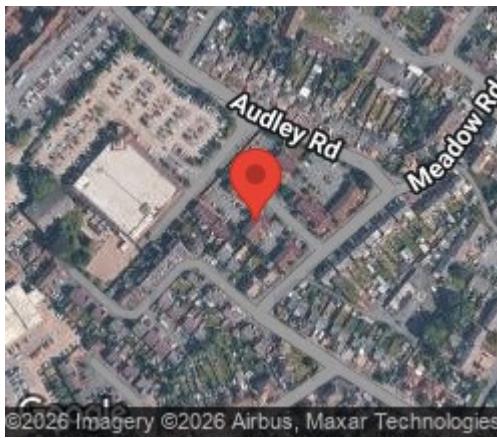

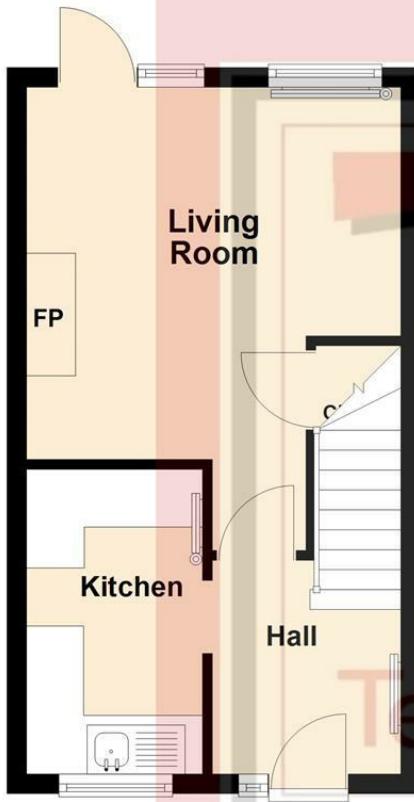

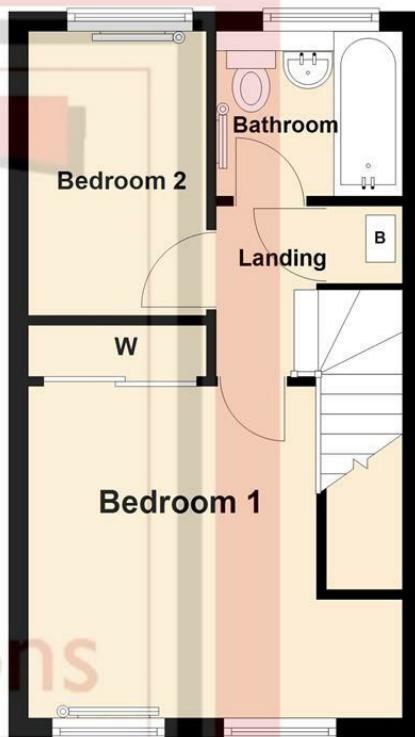
## Ground Floor
