Entering the building into a communal hallway with one flight of stairs to:

PRIVATE ENTRANCE HALLWAY

9' x 8'1" (2.74m x 2.46m)

A particularly spacious entrance hallway providing useful space suitable for a home office, vinyl floor covering, telephone intercom, electric heater, attractive period features.

KITCHEN

13' x 6'8" (3.96m x 2.03m)

Smartly appointed with a generous range of fitted wall and base units having matching cupboard and drawer fronts, laminate work surfaces, stainless steel sink and drainer, tiled walls, electric oven, hob and extractor fan over, fridge freezer and washing machine, vinyl floor covering, UPVC double glazed window, electric heater and high ceilings.

LOUNGE

18'2" x 9'10" (5.54m x 3.00m)

A charming lounge having a feature curved bay window opening to the side garden of the development, electric fireplace and electric heater, ample space for furniture, feature high ceilings.

BEDROOM

13'9" x 7'10" (4.19m x 2.39m)

Appointed with a modern shower room suite comprising a corner shower cubicle with folding screen doors, tiled walls and an electric shower, a wide wash hand basin sits on a vanity unit with storage drawers and cupboards, low-level WC with concealed cistern, vinyl floor covering, inset ceiling spotlights, extractor fan, mirror with cupboard and lighting, towel radiator.

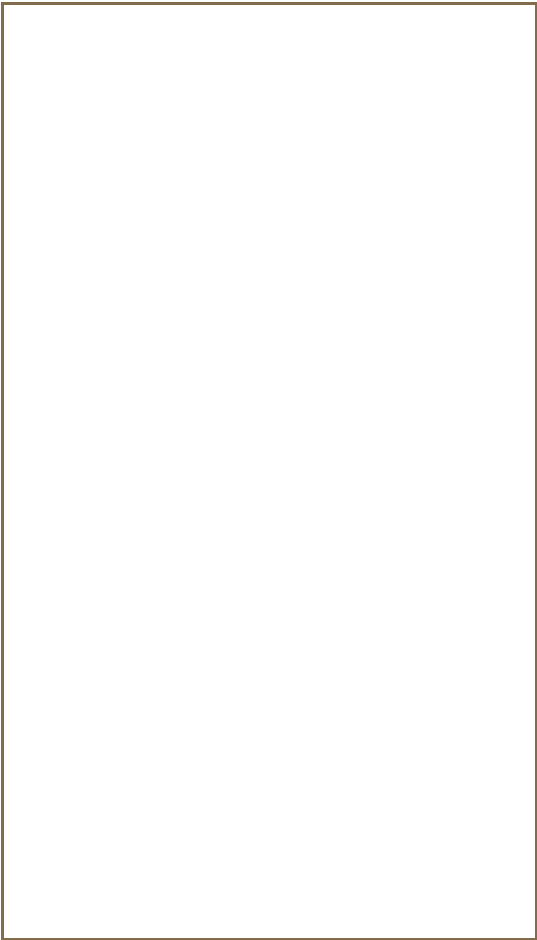
