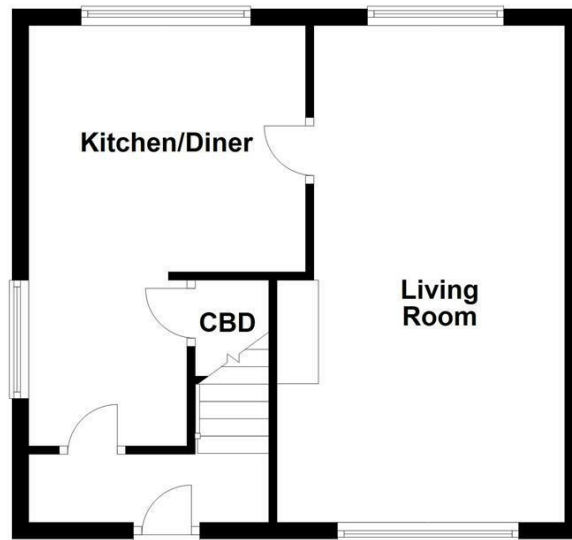

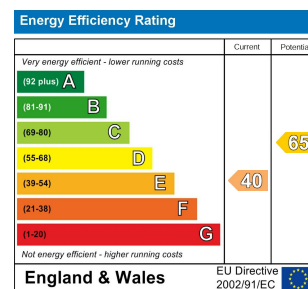
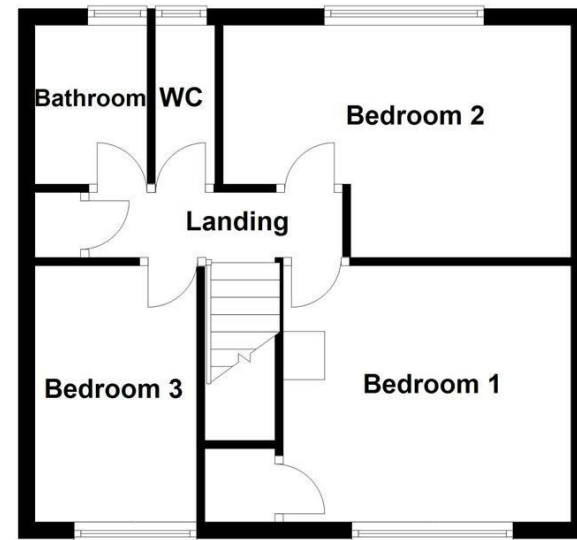

Central heating radiator, staircase to the first floor landing and door leading into the kitchen/diner.

Range of wall and base units with laminate work surface over and tiled splash back above, stainless steel sink and drainer with mixer tap, space for a freestanding oven and grill, space for a large freestanding fridge/freezer, space and plumbing for a washing machine, space for a dryer, central heating radiator and door providing access into the living room.
