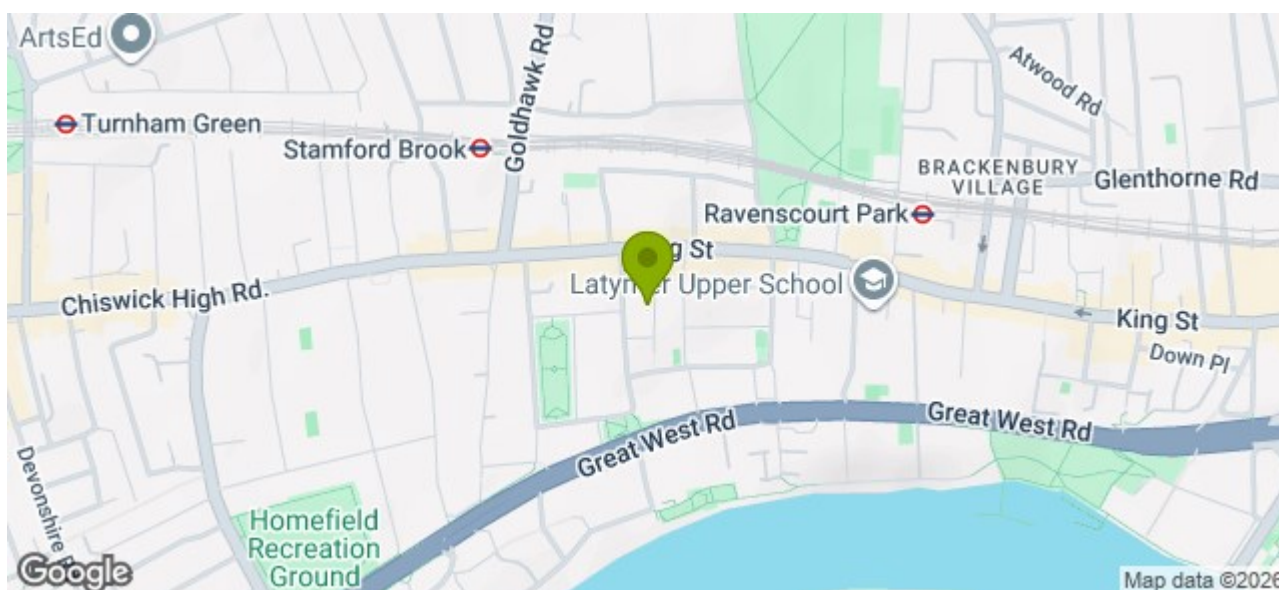

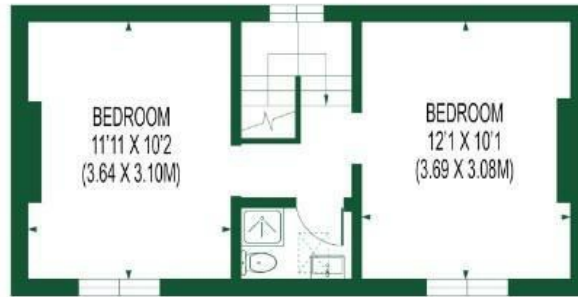




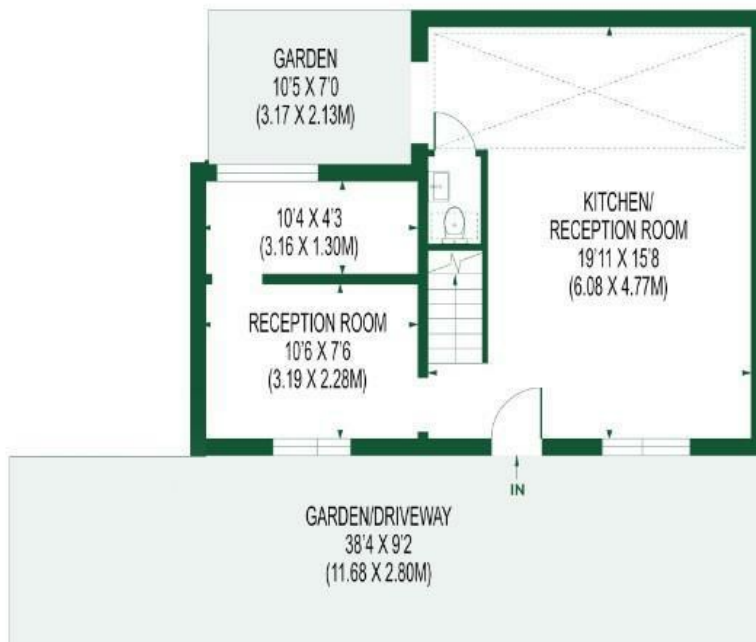
Floor Plan
