The first floor comprises a well-appointed bright kitchen/dining room, a very useful utility/shower room with underfloor heating and loads of storage, as well as a large double bedroom, front aspect reception room, and a study.

The beautifully fitted kitchen includes a fridge/freezer, dishwasher, instant boiling water tap, ample storage, and underfloor heating.

Stairs lead from the kitchen down to the private landscaped garden.

The utility/shower room also includes underfloor heating, a fitted washing machine, and more storage.

The top floor offers two large and light double bedrooms, a private roof terrace that has outside lighting and power points. Both bedrooms on the top floor have lovely en-suites. One of the en-suites has underfloor heating and a heated mirror. The property is fitted with a mega flow which means all showers are high pressure and there is more storage on the top floor in the eaves.
