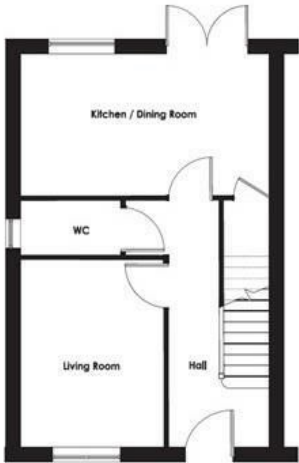
Floor Plan

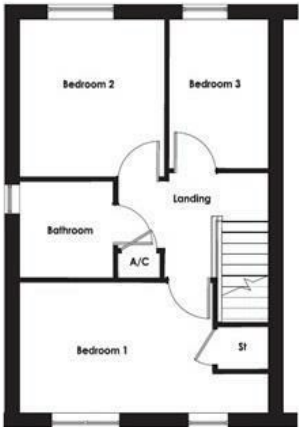

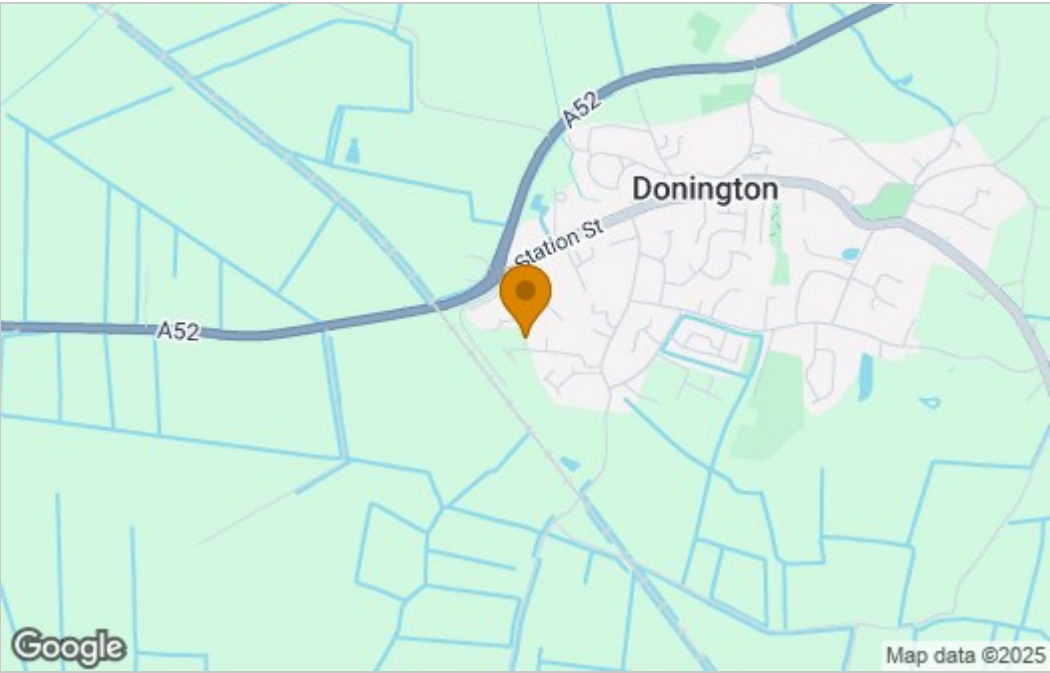

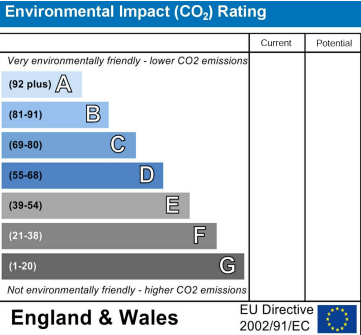
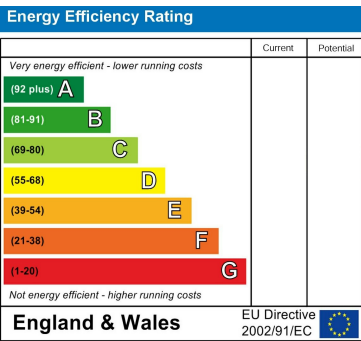
