Welcome to this unique dual-apartment property in the heart of Hisarönü.

Apartment 1 is situated on the ground/first floor and offers two generously sized bedrooms, each with fitted wardrobes. It features a newly refurbished family bathroom with a corner shower, a galley-style kitchen with dining area, and a separate front lounge with stairs leading down to the terrace and poolside.

Apartment 2 is located on the lower level and includes a double bedroom and a spacious triple bedroom, a family bathroom with shower cubicle, and an openplan lounge/kitchen with a built-in breakfast bar. This apartment also benefits from direct access to the poolside terrace.

Outside, the complex boasts beautifully maintained gardens, ample sunbathing areas, and plenty of quiet corners to relax and unwind.

The location is superb — just 25 metres to the nearest supermarket and a very short stroll into the vibrant centre of Hisarönü.

#### **Buvers Fee**

In accordance with Turkish Law, we charge the buyer 3% (inclusive of any Vat/Taxes that may be chargeable) of the agreed purchase price (unless agreed differently in writing), this is standardised throughout estate agency in Turkey.

#### Local property council tax (Emlak Vergisi)

Local property tax is payable in two equal instalments, the first in May and the second in November. You have to contact your local municipality (Belediye) for further information and payment options. Tax is calculated based on the value of the property and is subject to thresholds set by the tax authorities as follows:

#### Taxes payable when purchasing/selling a property

Turkish Property Transfer taxes (Emlak Alim/Satim Vergisi) paid by the purchaser.

#### Earthquake Insurance (Dask)

If the property is a building then Natural Disaster Assurance (DASK) is obligatory. From personal experience, the insurance cost is very reasonable.




