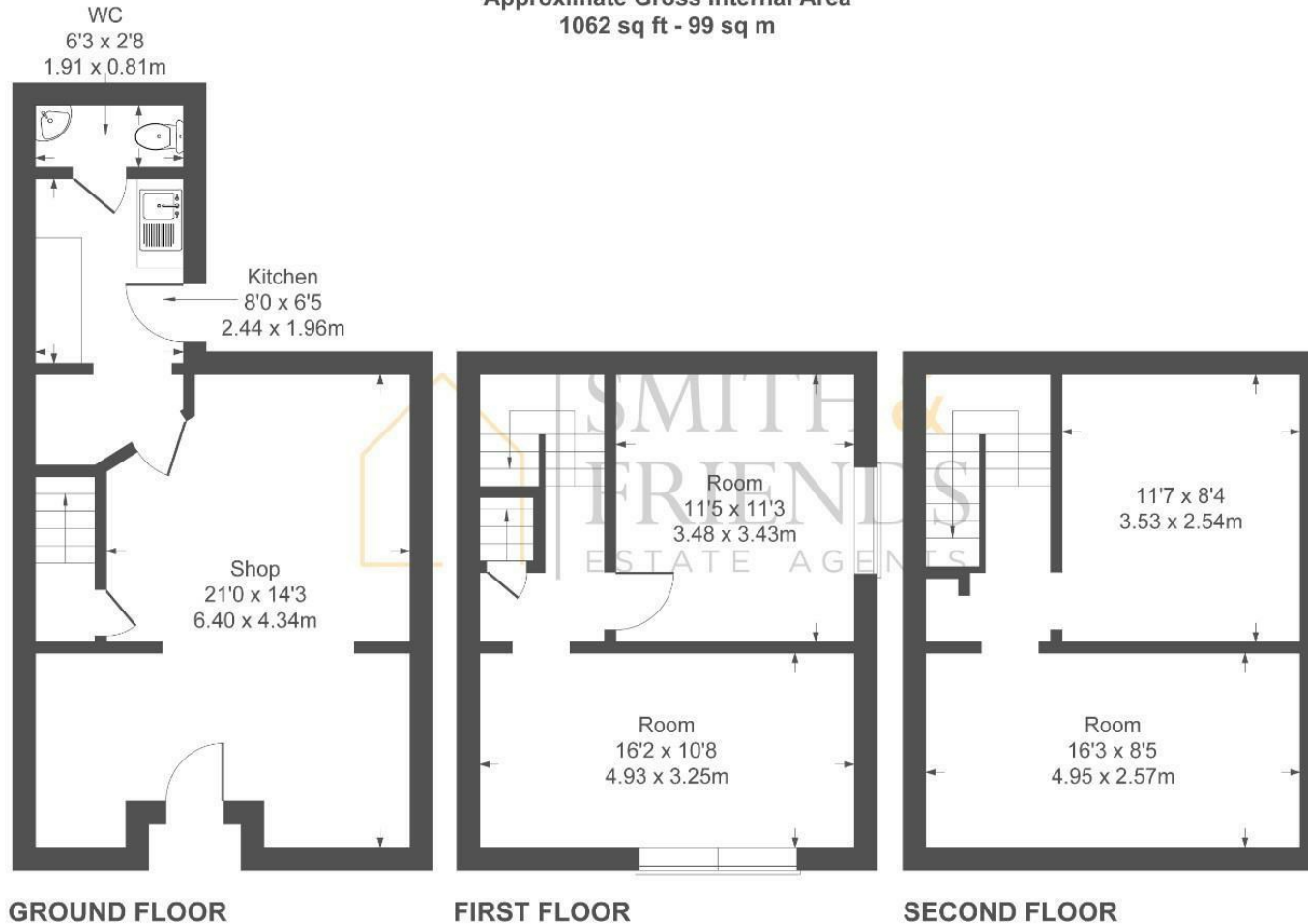

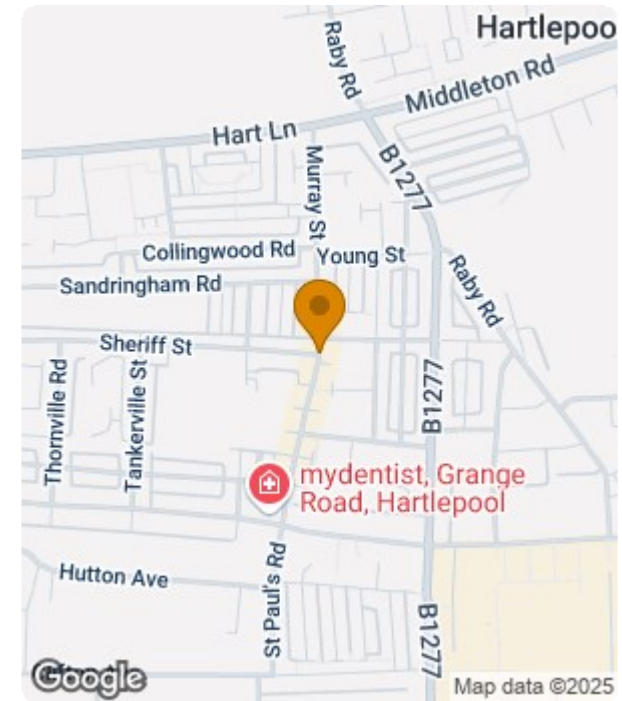


# Murray St
