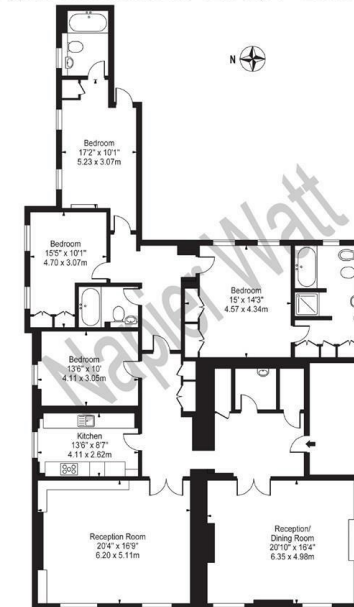
Eaton Square is widely regarded as the jewel in Belgravia's crown and undoubtedly one of the capitals most desirable
