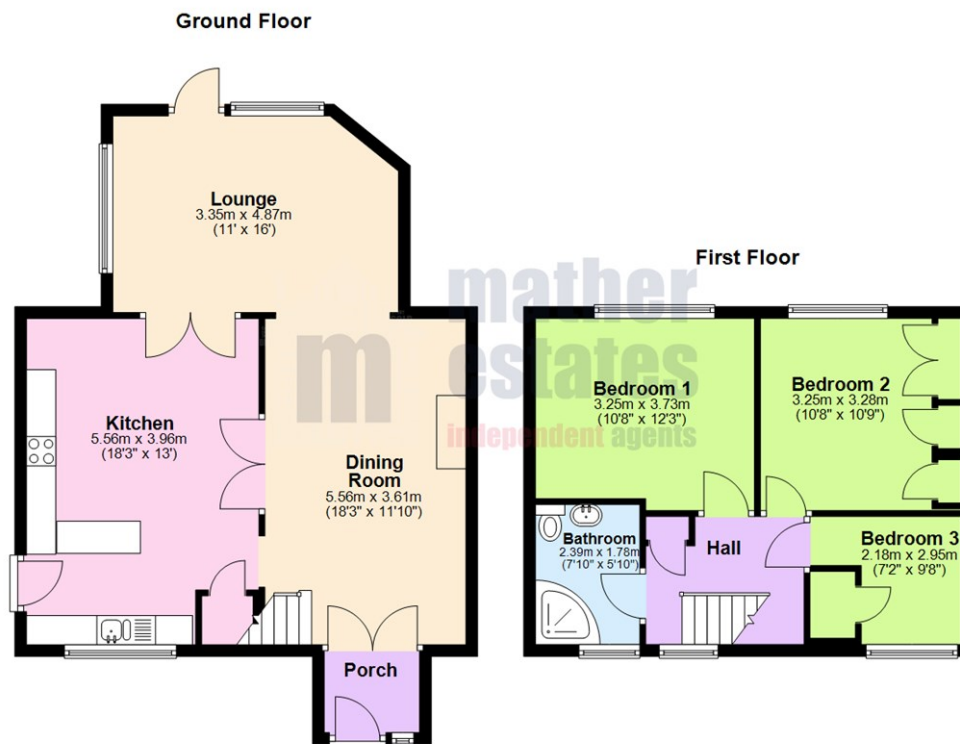
A great size with the house set back from the road behind a hedge, lawn, flower and shrub beds, various specimens and evergreens, gate to rear garden and access to the workshop.

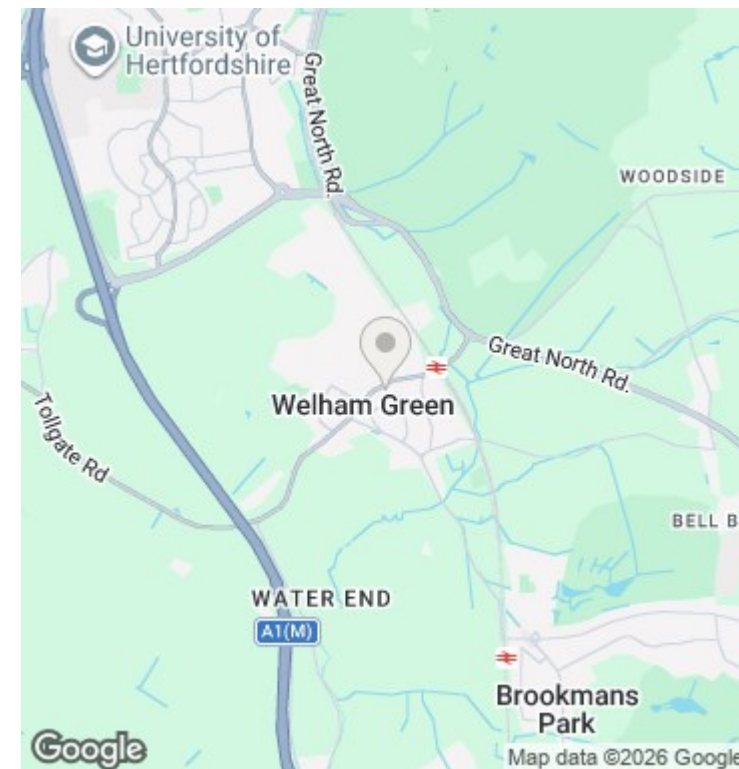
